# ARTICLES OF INCORPORATION

OF

## MONUMENT HILL SERTOMA CLUB

RESTATED AND AMENDED January 30, 2010

**ARTICLE I- Name:** The name of the Corporation is the Monument Hill Sertoma Club.

**ARTICLE II- Type:** The Corporation is a nonprofit corporation organized and existing without shares or capital stock.

**ARTICLE III- Period of Existence:** The Corporation shall have perpetual existence.

**ARTICLE IV- Purpose:** Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE V- Powers:** The Corporation shall have all corporate powers necessary to meet its purposes as stated in ARTICLE IV within the limitations set forth in ARTICLE IX and in accordance with the laws of the State of Colorado.

**ARTICLE VI- Membership:** The Corporation will have voting members.

**ARTICLE VII- Offices:** The registered office in the State of Colorado is located at 15642 Split Creek Drive, Monument, Colorado 80132. The name and address of the registered agent is Gorham Brady Stephenson, 15642 Split Creek Drive, Monument, Colorado 80132.

**ARTICLE VIII- Statement of Property:** The private property of the incorporators, members, directors, and officers of the Corporation shall not be subject to the corporate debts or corporate liabilities to any extent whatsoever.

**ARTICLE IX- Power Restrictions on Members and Others:**

1. No part of the net earnings of the Corporation shall inure to the benefits of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE IV hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or

otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these ARTICLES, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

2. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes

**ARTICLE X- Affairs of the Corporation:**

1. The affairs of the Corporation are to be under the control of a Board of Directors consisting of a number as will be prescribed from time to time in the Constitution or Bylaws of the Corporation, provided, however, that under no circumstances will the minimum number be less than three. The terms of office and the method of election of new Board members will be as set forth in the Constitution or Bylaws.

**ARTICLE XI- Board of Directors:** The Board of Directors is expressly authorized to make, alter, amend, or repeal the Bylaws of the Corporation.

**ARTICLE XII-Articles Amendment:** The Corporation reserves the right to amend, alter, change, or repeal any provision contained in these ARTICLES OF INCORPORATION in the manner now or hereafter prescribed by statute, and all rights conferred upon its members are subject to this reservation.

**ARTICLE XIII- Names and Addresses of Original Incorporators:**



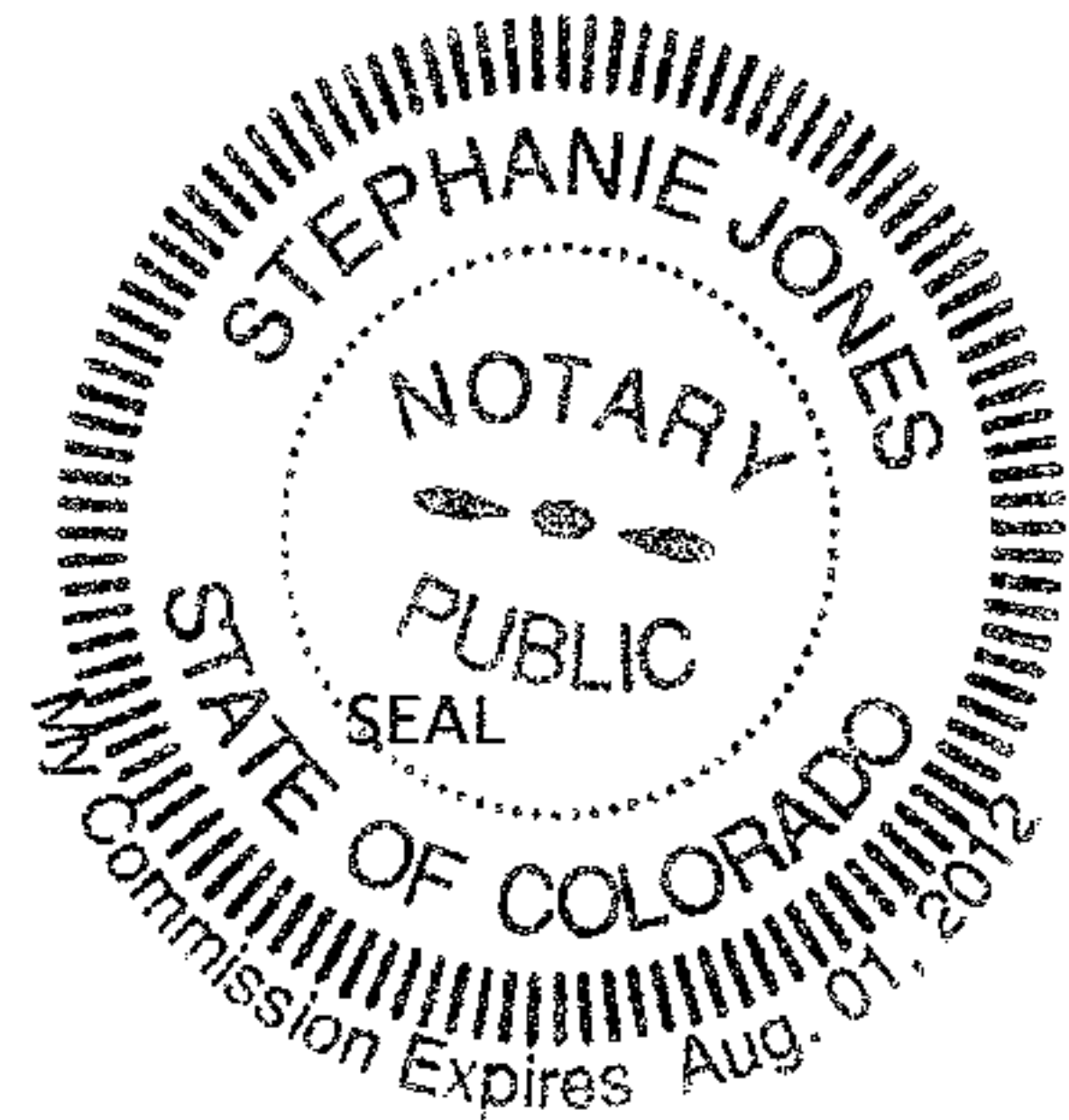
